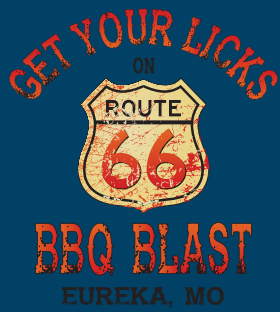

## EVENT RULES & REGULATIONS

- The Entry fee for the competition is \$225 unless you are a first responder team and only participating in the Saturday night Pork Steak category (\$50.00 fee for first responder teams). The full fee must be received with every application no later than July 31st (or until event is sold out) to reserve your spot in the competition. Checks should be made payable to: City of Eureka, Mailing address: 100 City Hall Drive, Eureka, MO 63025 Phone: (636)938-5233. Credit cards are also accepted.
- MANDATORY pit master meeting on Saturday, August 4th at 2:00 p.m. at the Community Center.
- St. Louis County Requires a Health Permit for each team if you plan on vending. Additional \$50 fee to City of Eureka to sell to the public. You are responsible for getting your own health/food license from St. Louis County. Information regarding this permit can be obtained by calling 314-615-0921, or at the following website: [www.stlouisco.com](http://www.stlouisco.com) The permit is called Temporary Food Establishment Application.
- Each space is 20' x 20' with 20 amps of electricity. Water is available on-site. Please bring your own extension cords and containers for water. No generators are permitted.
- Set up will begin in Legion Park on Friday, August 3rd from 2:00 p.m. - 8:00 p.m. and then resume at 6:00 a.m. or after on Saturday, August 4th. Meat check-in will begin at 8:00 a.m. or upon arrival. Meat must be unrubbed and not marinated as well as the proper temperature. All teams must be loaded in by noon. Please note on your registration form if you have an unusually large bbq set up so that we can work to make your set up experience more convenient.
- Guns & Hoses Showdown participants may break down after 8:00 p.m. Saturday evening. Awards will be given by 9:00 p.m. at the bandstand.
- Overnight security will be in place on Saturday night and quiet time will begin at 11:00 p.m. until 8:00 a.m. the next day. Site must be torn down and free of litter by 8:00 p.m. on Sunday.
- Judging: Saturday at 6:00 pm for Guns & Hoses Showdown and Sunday beginning at noon for all other categories with turn in times of 12:00 p.m., 12:30 p.m., 1:00 p.m. and 1:30 p.m. This is a sanctioned event by the St. Louis BBQ Society and will be judged according to their rules and regulations. - All booths must have an A.B.C. approved fire extinguisher and all electrical booths must have a 100 foot outdoor orange extension cord.
- The BBQ cook-off committee reserves the right to reject any application. Event is rain or shine. NO REFUNDS WILL BE MADE ONCE YOU HAVE BEEN ACCEPTED IN THE CONTEST.
- NO motorized vehicles such as golf carts, gators, 4-wheelers, etc. are permitted.
- Restrooms are on-site.
- No RV/Trailer hook-ups, please.
- Awards will be presented at 4:00 p.m. on Sunday, August 5th
